

## R.S. Prussia Auction Policy

The following terms and conditions have been approved by the R.S. Prussia Officers and Directors.

The auction is awarded on a yearly basis by the Board, preferably in the last Convention Board Meeting of current year. That auction company is to be notified by the President and also an announcement put in the October Newsletter of same current year.

The President is to send the policies to the auction house that has been selected.

### Policies:

1. The licensed auction company needs to be a member of the International.

2. The RS Convention Auction should not exceed more than 270 lots.

3. Items sold shall be in the RS Prussia family (i.e., RS Germany, RS Poland, ProvSaxe, Royal Vienna, ES).

4. The auction company shall list the items by number and sell in numerical order.

5. Any add ons above the 270 pieces must have the approval of the President.

6. Any approved add ons must be listed in the official catalog. There cannot be any add ons once the catalog is published.

7. Viewing times will be scheduled for Friday afternoon or evening and also auction viewing 2 hours prior to auction.

8. Auction on Saturday at 12:00 noon. ★

# Board Meeting

Thursday, July 22, 2010 10:00 am

R.S. Prussia Convention, St. Louis, Missouri, Holiday Inn, Souldard Room

## Call to Order

### A. Welcome – Terry Coy

Terry welcomed everyone to the convention and meeting. The meeting was convened at 10:09 a.m.

### B. Approval of Minutes from the last board meeting

Linn Schultz motioned to accept the minutes as recorded. Beth Vandermeer seconded the motion. A vote was taken and the motion passed unanimously.

## Old Business:

### A. Committee Reports

#### 1. Nominating Committee – Bob Yaklin, Chair

Bob Yaklin reported that all officers terms have ended and 2 of the board members terms have also ended. Only Harold Dodds has 2 years left and has offered to accept the board appointment for another 2 years. Bob does have potential candidates for all of the openings and is still working on this.

#### 2. Budget Committee – Linn Schultz and Richard Hartzheim

Richard reported that we have met all the budget guidelines. Linn Schultz moved to accept the current budget. Allan Marcus seconded the motion. A vote was taken and the motion passed unanimously.

### B. Membership Roster By-laws

#### – Terry Coy

Terry suggested that we amend the by-laws to allow a past officer to be able to take another term of office. He stated that we could make a suggested revision of the amendment but that revision would have to be voted on by the general membership. The revisions would be to Article 9 of the current by-laws.

After much discussion the following revision was suggested:

“After a 4 year hiatus from an elected position a member can again be eligible for any previously held elected position.”

Linda Titus motioned to present the above change to the general membership. Dick Hartzheim seconded the motion. A vote was taken and the motion passed unanimously.

### C. Website – Terry Coy

Terry announced that the video part of the home page is now working. He posed several questions to the board. They were 1) how often should changes be made? 2) what should Allen be allowed to change? 3) who should notify Allen when changes need to be made? and 4) who does Allen report to. Discussion followed and Linn made a motion that changes be made quarterly and/or when the President requests changes.

The President will decide what Allen should be able to change and that Allen would report to the President. Motion was seconded by Beth. A vote was taken and the motion passed unanimously.

### D. Membership

#### 1. Committee Report – Larry Bazaar and Beth Vandermeer

Suggestions from the round table committee included that the problems we have, other clubs have too. There was a big push to continue the DIYA. It was suggested that the round table discussions be omitted for a few years.

### 2. Dues incentives and deadlines

#### – Karla Hartzheim

Karla reported that deadlines for dues are still not being followed no matter how many times members are reminded. Karla was going to start collecting dues for the coming year at this convention. Due to the heavy volume at registration time it was too difficult to explain dues collection too. The committee felt that it would be best to start this procedure at the next convention. A suggestion was that the dues invoice could be put into the convention packet.

### E. Convention 2010 Report – Terry Coy

Terry reported that everything has gone very well with this hotel. Terry reported that the AV equipment that we have needed was provided free by the hotel. He also announced that Melinda Woody will let us use their AV equipment for the Rare and Unusual seminar.

Terry reported that he has had contact with a hotel in Cincinnati, Ohio. This will be discussed at the board meeting on Saturday and Terry and Allen will be talking to the auctioneers before a decision is made

### C. Treasurer's Report – Richard Hartzheim



### Call to Order – Terry Coy

#### A. Welcome – Terry Coy

Terri welcomed all that were present. The meeting was called to order at 8:37 AM

#### B. Role Call of States –

Allen asked that as he read each state, members from that state should stand.

#### C. Moment of Silence –

#### D. Minutes of 2009 Convention

##### Business Meeting – Karla Hartzheim

Karla read the minutes from the last business meeting in Dublin. Howard Greenberg made a motion to accept the minutes as read. John Titus seconded the motion. The motion passed unanimously.

#### E. Introduction of Officers and Board Members – Terry Coy

All Board members and officers were introduced.

#### F. Nomination Committee – Slate of Candidates, Nominations, Vote

Bob Yaklin asked for nominations for

the following positions: President, VP, Secretary, Treasurer, and 2 Board member positions. For all of these positions the terms are expired. For board members, Larry Bazaar is still in office and Howard Dodds, Jr. has accepted another term. After nominations from the floor, the following slate of candidates was formed:

President – Allen Di Marco (moved to accept by Paul Fischer, 2nd by Howard Greenberg)

Vice President – Nadine Sidmore (moved to accept by Paul Fischer, 2nd by Dannie Chandler) and Allen Marcus (moved to accept Linda Titus, 2nd by Howard Greenberg)

Secretary – Mary Lou Bougher (move to accept by Selma Greenberg, 2nd by Dannie Chandler)

Treasurer – Ken Bougher (move to accept by Selma Greenberg, 2nd by Dannie Chandler)

Board of Directors – Paul Fischer (move to accept by Nadine Sidmore, 2nd by Dannie Chandler) and Judy Bazaar (move to accept by Norma Tackett, 2nd by Paul Fischer)

C.L. Riley moved to accept the slate

of candidates as presented. Howard Greenberg seconded the motion. A vote was taken and the motion passed unanimously.

C. L. Riley moved to accept by acclamation the nominees (except for VP) as the new officers for the RS Prussia Association. Walt Krzycki seconded the motion. A vote was taken and the motion passed unanimously.

Ballots were passed out for the position of VP. Candidates are Allen Marcus and Nadine Sidmore. In addition to this vote the members will also vote on an amendment to Article 9 of the Association by-laws. At the first board meeting of this convention the board discussed length of terms for officers. Once you have been an officer for 4 years/2 terms, you are no longer eligible to be voted into that office. The board felt that there might be individuals that would like to stay on the board for a longer period of time. However, the board also felt that it would be necessary to take a break from office. With that in mind Linda Titus made a motion to amend the by-laws. The following is the change:

**“After a 4 year hiatus from an elected position a member can again be eligible for any previously held elected position.”**

The motion was seconded by Dick Hartzheim. A vote was taken and the

motion passed unanimously. The change to the by-law must be voted on by the general membership. The change is on the back of the voting ballot.

Ballots were passed out to the membership; members voted and returned votes to the Nominating committee for a tally. The results of the votes will be announced later in the meeting.

#### **G. Hospitality Report**



#### **H. Auction – Allen Di Marco**

Allen announced that raffle tickets are being sold this year. This will be a money raffle. After all monies are collected, 50% will go to the association and 50% to the winning ticket holder.

#### **I. Do-It-Yourself Auction – Howard Greenberg**

remember to bring pieces to auction and to buy at the auction. This is one of our major money makers for the club.

#### **J. Treasurer’s Report – Richard Hartzheim**

The full Treasurer’s report is attached to the agenda. Dick reported that there were a few large items that the club had to pay for this year. They included \$2,750 for the new website and extra charges for the hotel expenses in Dublin. Due to these extra expenses, the CD that belonged to the club has been used to pay for the expenses. The good news is that the club is still self-sustaining. Dick also reported that other than the above expenses, we remained within the budget for everything else. Dick reported that the money given to us by the auctioneers, the DIYA, and the raffle are our major sources of income.

#### **K. Secretary’s Report – Karla Hartzheim**

Karla presented the secretary’s report. It is attached to the agenda.

#### **L. Election Results**

After a very close vote, Terry announced that Nadine Sidmore will be the new VP and that the change to the by-laws was passed 84 yeas/ 4 nays.

## Board Meeting

Call to order:

#### A. Welcome: Allen DiMarco

Allen, the newly elected President welcomed the newly elected officers and Board members. Terry Coy attended as immediate Past President.

#### B. Approval of Minutes from the last board meeting

The minutes of the last board meeting were read by new Secretary, Mary Lou Bougher. Larry Bazaar made a motion they be accepted as read. Seconded by Harold Dodds, Jr. A vote was taken and the motion passed.

#### Old Business:

##### A. Website: Allen Marcus

###### 1. Impressions

Most of the new officers and board members have not seen the new website. Ones that have seen it liked the more varied pictures including more florals.

###### 2. Suggestions for changes/additions

Allen stated that he sees himself as Website liaison and that he is still learning. The new website has more varied pictures. Mary Lou stated she has more pictures of fakes and new “blanks” and she will send to Allen for posting on the fakes section. We don’t know how many hits the website is getting and wonder about the possibility of obtaining this information. Terry will contact Justin to see if this is possible. A discussion of how we can keep the website updated and varied. Rick and Joleen are still listed as contact people on the site. Terry explained we are no longer letting everyone post items for sale due to the possibility of liability if someone sold items that were not as described.

##### B. Do-It-Yourself Auction

1. Howard Greenburg came in and reported that the Do-It-Yourself auction proceeds were \$2412.35 and that we had a much larger attendance this year. Larry and Judy Bazaar were thanked for

being the largest contributors to the DIY auction over the years, Howard said we try to have a \$20.00 minimum bid but this is not always possible due to small or damaged items.

#### C. Seminars

1. We discussed seminars for next year and Ken Bougher said he would do one and Beth VanderMeer would again do the “Rare & Unusual” program again as it is very popular.

#### D. Other Old Business

1. Linda reminded all officers and board members they are required to do at least one article for the newsletter. A sign up sheet was passed for us to sign up for the issue we would do. Linda stated that the articles need to be to her at least one month ahead of publication date.

#### New Business:

##### A. Robert’s Rules

A discussion was held on “Robert’s Rules of Order” and Allen reported that in general, we do follow them but it is not required.

##### B. 2011 Convention

1. Terry reported on past problems of finding auctioneers that are licensed to do auctions in some states. Kentucky laws only allow an auctioneer from another state to have 1 auction in their lifetime. Woody Auction has used John, Janine, and Jason but Marshall’s voice is not strong enough as he has not been doing it regularly.

Paul suggested we consider Davies of Indiana who is a good auctioneer. He is honest and had pretty good results. Terry reminded us that the auctioneer must be a member of RSP Inc. With that and licensing problems; we are limited in who we can have as auctioneer.

A suggestion was made that we rotate the convention site between Ohio, Indiana, and Missouri. Board felt this would be good idea. Suggestion was made that

we offer an auctioneer a 5 year commitment. Board decided against this. Board felt a 1 year commitment was sufficient. Motion made by Allen that we award the 2011 convention auction to Jim Wroda. Second by Terry. Voted and approved.

2. Terry reported he and Allen have visited the Marriott just outside of Cincinnati and the Marriott proposed a room rate of \$105.00 per night plus tax which would include breakfast. One problem with the contract is a \$2300.00 penalty if we did not meet the number of banquet meals set way before the convention. This is not acceptable. Allen reported that the current year's hotel did not charge us any extras for which other hotels have charged us in the past such as sound equipment. They only charged us for the banquet which of course was paid for with banquet reservations.

The Marriott's regular room rate is \$149.00 per night and they proposed \$105.00 plus the tax of 12 1/2% tax per night which would include breakfast. They would also include a free ice cream social. Negotiations will continue with the Marriott as well as checking out other possibilities. Larry made a motion we go forward with the Cincinnati area. Seconded by Allen. Voted and approved.

3. Discussion of problems with this year's pet policy was held. Terry told of at least 1 problem that kept a member from coming due to an error by a hotel employee as to what the pet policy was in our contract.

4. Nadine told us of a suggestion from the roundtable discussion of the possibility of a "sale room" that the general public would be invited to attend. This is done by the lamp collector's convention, This would possibly encourage someone to join and would make us more visible to the community where the convention was held. Paul will check on the tax issues in doing this. Board will defer action until more information is obtained.

5. Another suggestion was to have a "Antique Roadshow" type event inviting local people with possibly Paul and Danny to do the evaluations. Further investigation to be done.

6. Mary Lou reported on complaints that we were spread out on 8 floors with other hotel non RSP guests and the problems with the extra walking this was causing. Also this caused problems with members who had displays or were selling having to be away from their rooms longer due to being spread out and a lot of people could not get in to see some rooms. Terry reported we were supposed to be on 5 thru 8 but some other guests did not leave their rooms when they were supposed to check out so we couldn't be together.

#### **C. Membership Brochure**

A motion was made by Linda that we keep the present brochures and put a sticker over Karla's name and address with Mary Lou's address on it. Also that we keep the membership fee as listed in the brochure of \$30.00 for first time members only. Seconded by Nadine. Voted on and passed.

Allen DiMarco suggested that the new secretary get a post office box so we are not posting our home address. He also suggested the next time we have the brochures printed we not include the secretary's address so we can just add labels as name and address changes.

#### **D. Appointment of editor/publisher**

Allen DiMarco recommended we keep Linda Titus as Editor/Publisher for the newsletter. Linda noted that we have checked prices and she is still the best price for our publishing. Linda was appointed as Editor/Publisher of the newsletter. She accepted the appointment.

#### **E. Appointment of Historian**

Allen reported that Mary Lou would like to keep the position of Historian as long as it does not interfere with her duties as secretary. She will see how it works next year and we can go from there. Allen thanked Mary Lou for the

work she has done in all the past years and appointed her again.

#### **F. Newsletter**

1. Motion made by Mary Lou that we again publish auction prices in newsletter either in the newsletter itself or a separate sheet inserted in the newsletter per Linda's discretion within the budget. Motion seconded by Allen Marcus. A discussion was held on the problems caused by eliminating the auction results with the members and especially for those who could not attend the convention. Motion voted on and passed.

2. Suggestion was made that we go electronic on the newsletter and roster. Terry pointed out that this is what we have to offer members that can't attend the convention and to give it up and just do e-mail would lose us members and not give incentive for others to join

3. Suggestion made by Larry that we re-use some of the old articles in the newsletter. Linda reported that this had been done before and that it was a good idea as new members would not have seen them.

4. Allen suggested we offer business card sized ads for sale in the newsletter. Linda said the extra cost of including them might not benefit the club due to printing restrictions.

5. Ken suggested we interview some long time members for articles in the newsletter. Ken will start this with one

### H. Roundtable Report

1. Beth reported concern over policy of no refunds of convention registration if unable to attend. Discussion on how number of paid registrations and banquet is how we base numbers to hotel. Decided to keep policy as it is with possible change of wording.

2. Another suggestion from Roundtable meeting was to suggest adding a donation line to the membership renewal forms. Further investigation to be done on whether this would be tax deductible. The way our current charter is set up they would not be tax deductible. We can still add the line.

3. Suggestion made in roundtable that we contact local media and put articles in antique papers in January with pic-

tures. Mary Lou reported she has taken room display pictures we could use in articles promoting the coming convention so people could plan ahead for vacation at that time.

4. "How you got started" articles for newsletters

5. Bring a friend to convention.

6. Auction off 3 blocks of 2 seats for the regular auction at the Do-It-Yourself auction. High bidders would get choice of 2 seats in regular auction and 15 minutes free preview time before rest of public allowed in to preview. Also would receive a possible "goody basket" with bottled water and other items. Someone will check with Auctioneer for permission to do this next year. It would be called VIP seating. Linda volunteered to auction them off in the DIY auction.

7. Suggestion to advertise 50/50 drawing in newsletter for those unable to attend convention.

8. Suggestion to get more membership brochures out to members to give to public.

9. Decided to have another "Roundtable" next year.

10. Suggestion made to give someone you love or a friend a small piece of RSP that might ignite an interest in collecting.

11. Give customers on eBay or at shows who purchase RSP a free membership out of your profits and maybe get them interested.

### I. Other New Business

Discussion as to whether we should require a donation from any auctioneer who does the convention auction. Consensus was that long ago the club suggested a 5% donation but it hasn't been required lately. We have only had one time that a donation was not given. Woody Auction donated \$1500.00 to the club this year from the auction. Decision to leave policy open as the only time we weren't given a donation was by an auctioneer who is no longer in the club.

### J. Adjournment

Motion made by Terry that we adjourn the meeting. Second by Beth. Voted and passed. Adjourned at 10:30 a.m.

The couple was elderly, moving into a retirement center and their children didn’t want “all those dishes” to deal with. We carefully packed and moved the collection to our auction where the real fun began. Word circulated about the upcoming auction and the phone started ringing. Some of the questions coming in such as, “Any point and clover mold or icicle mold items?” “Are there any pieces with Man-in-the-Mountain scene or possibly 4-scene barnyard?”

I told the callers that I didn’t have that information yet as we had just started unpacking. Then I did the next most logical thing and asked Larry if he had any idea what “mold” or “decoration” meant. His blank 1000 yard stare spoke volumes, neither of us had a clue.

“Houston we have a problem!”

A rush trip to the mall bookstore ensued and with reference books in hand I thought, well this shouldn’t be so hard. That thought didn’t last long. It took me days to identify each piece by the mold and decoration. All the time questioning the sanity of anyone that used this method of identification as I couldn’t seem to see past the decoration to determine the mold. There had to be some simple line drawings without the decoration that would make the process easier. I was convinced this was a conspiracy to drive me nuts and it was going to be a very short trip. After days of concentration, it began to make some sense.

As a result of this experience, I have a lot of empathy for the new collector or novice in the field of RS Prussia identification. Now when I ask a new collector what mold or decoration a certain piece has and I receive that blank look, I know exactly what is going on in their brain. I am able to use the opportunity to share what I so painfully learned many years ago. ★
